AOBFP Longitudinal Assessment (LA)

Please note that once you register for the Longitudinal Assessment, it will take up to seven business days to review your application and activate your account in CATALYST. Candidates are encouraged to register at least two weeks before the end of the quarter to be able to participate in the assessment. Candidates will have access to all incorrect or unanswered items during the remediation period.
