I would like to thank the members of the AOBPM&R Board and the American Osteopathic Association (AOA) PM&R Certification Director for their tireless efforts, dedication, hard work, and support over the last several years. We have accomplished a great deal over the past three years. Our AOBPM&R board members possess a great deal of knowledge, experience, and understanding in assisting our AOA PM&R diplomats with continuing as lifelong learners while sustaining their careers. 
- **September 2024:** 2025 Longitudinal Assessment Registration
- October 17, 2024: AOBPMR Written Part I Exam
- April 5, 2025: 2025 AOBPMR Oral Part II Exam
- **September 2025:** 2026 Longitudinal Assessment Registration
- October 16, 2025: AOBPMR Written Part I Exam

AOBPMR CME REMINDER

This is a friendly reminder that the AOBPMR 2022-2024 CME cycles closes on **December 31**, **2024.** Please see below the requirements of the CME.

Physical Medicine & Rehabilitation (AOBPMR) Time-limited diplomates or non-time-limited diplomates voluntarily participating in OCC.

- 75 credits of CME with 18 credits AOA Category 1-A CME
- Non-time-limited diplomates not participating in OCC are required to complete 120 credits of CME 30 of which must be AOA Category 1- A CME.





AOBPMR SME ITEM WRITERS NEEDED

The American Osteopathic Board of Physical Medicine Rehabilitation (AOBPMR) is searching for Item writers to join our Exam Writing Committee as Subject Matter Experts. The Exam Writing Committees for the Initial, Oral, and Longitudinal Assessment are led by an outstanding group of physicians. We have an ambitious timeline for this year's exam writing, and we know that we can meet it with your participation.

What is an Item Writer?

Item writers offer their expertise and develop items (examination questions) for AOBPMR's computer-based, written, and oral examinations. Item writers must be boardcertified by AOBPMR.

What is expected of Item Writers?

New item writers will need to complete an online AOA item writing training module before participating. Item writers participate in content development for board examinations each year - this can be achieved remotely via assignments determined by the examination committee.

What are the benefits of item writing?

Item writing offers many benefits, including CME, professional development recognition, member discount and waiver for OCC Component 3 (Longitudinal Assessment) for physicians participating as significant contributors, and other benefits as your participation grows. You will also be considered a significant contributor if you consider being an SME. Please see attached the criteria for being a significant contributor. As well as the requirements and benefits.
