

What is (Osteopathic) Neuromusculoskeletal Medicine?

Neuromusculoskeletal medicine (NMM), now more formally known as Osteopathic Neuromusculoskeletal Medicine (ONMM), is a medical specialty of American osteopathic medicine. Physicians trained in the specialty focus on the clinical evaluation and management of disorders of the neuromusculoskeletal system and its related visceral and somatic structures. Neuromusculoskeletal medicine is a specialty which is dominated by DOs, but MDs may also become certified. ONMM physicians complete residency training that includes advanced training on the integration of osteopathic principles into inpatient and outpatient care. They have specialized expertise in the indications, risks, benefits, and application of osteopathic manipulative medicine (OMM) for treatment of patients with neuromusculoskeletal and visceral disorders.

ONMM1 Residency Pathway

- All ONMM programs are ACGME accredited
- Residents enter program through the NRMP match during 4th year
- Program length is 3 years
- Eligible for primary certification through AOBNMM after completion of training

- Residents must have a postgraduate year in one of the following:
 - ACGME-accredited rotating internship
 - ACGME-accredited preliminary internship in NMM
 - ACGME-accredited family medicine PGY-1 year OR ACGME-accredited PGY-1 year in any other specialty where the resident is able to obtain broadbased education

ONMM3 Residency Pathway

- Residents must have completed an AOA/ACGME-accredited training program
 - Residents must have completed 12 months of rotations that could be applied to ONMM
 - Residents should show significant Osteopathic component in their training
 - Recommended that residents complete 300 ONMM outpatient visits, 15 inpatient ONMM consults, and 15 treatments in the following areas:
 - Pediatrics
 - Surgery
 - Ob/Gyn




