This is a friendly reminder that the AOBD CME is due on **December 31, 2024**. Please see below the requirements of the CME.

Dermatology (AOBD) Time-limited diplomates or non- time-limited diplomates voluntarily participating in OCC.

- 60 credits of CME 20 credits AOA Category 1-A CME All 20 Category 1-A CME must be specialty-specific
- Dermatology (AOBD) Non-time-limited diplomates not participating in OCC 120 credits of CME 20 credits must be AOA Category 1- A CME All 20 Category 1-A CME must be specialty-specific.
